The IRS mandates that certain foundation documents, such as the federal tax return (990-PF), be publicly available at a physical location. To facilitate compliance, Foundation Source maintains a Delaware office that is available to all of our clients for this purpose.

3 Active Compliance Monitoring

We monitor all foundation transactions processed through Foundation Source, as well as other activities that are reported to us by the foundation, to **HELP ENSURE COMPLIANCE** with IRS regulations.

KEY FEATURES

Verification of Each Grantee's 501(c)(3) Status as a Public Charity

Prior to releasing funds, Foundation Source reviews proposed grantee organizations to confirm that they are recognized by the IRS as valid 501(c)(3) public charities in good standing. For organizations not included in the IRS database (the IRS Business Master File Exempt Organization Extract), our charity research team will investigate the exempt status of potential grantees and provide guidance in the event that a proposed grantee is not a public charity.

USA PATRIOT Act and Executive Order Due Diligence

Foundation Source checks grantee organizations against national and international watch lists of known/suspected criminal or terrorist organizations and individuals.

Grants and Expenses

Our team of knowledgeable and highly trained professionals apply compliance checks and protocols to all disbursements before they are processed. When we become aware of grants or expenses that may violate IRS regulations (e.g. self-dealing, jeopardizing investments, taxable expenditures, excess business holdings, etc.), we alert you, and provide guidance and alternative approaches.



5% Minimum Distribution Requirement

We monitor the foundation's progress toward meeting its 5% annual distribution requirement. You can track this progress via our secure web platform.

Board Memberships and Affiliations with Other Nonprofits

Grants going to charities that are controlled by foundation insiders are flagged for special oversight. In order for such grants to count toward the foundation's 5% minimum distribution requirement, those funds must be disbursed promptly by the grantee. We ensure that both you and the grantees are aware of these rules.

Substantial Contributors

We identify and track significant contributors to the foundation, who are considered foundation insiders and therefore subject to self-dealing and other compliance regulations.

Identification of Supporting Organizations

Some public charities, such as a university's alumni association, are special types of exempt entities called supporting organizations that require additional due diligence on behalf of the granting foundation. Foundation Source identifies these organizations and works with you to review alternate granting options, such as expenditure responsibility, that will accomplish your charitable intent while remaining in compliance with IRS regulations.

Annual IRS Form 990-PF

Quarterly Estimated Taxes

Foundation Source calculates and sends payment to the IRS for the foundation's quarterly estimated excise taxes.

Year-End Forms 1099 and 1042

We process payments and reimbursements to outside vendors, professionals, and independent contractors, and prepare and distribute the completed 1099s as applicable (1042s for non-U.S. citizens doing business in the U.S.).

State Filings

Foundation Source handles all filings required by the state in which your foundation is domiciled, as well as for other states where filings may be required, when requested by the foundation. This may include tax returns, franchise taxes, and other registration requirements. (Additional fees apply for foundations required to file in multiple states.)

Year-End Substantiation Receipts

We send letters to all foundation donors, as required by federal tax laws, to substantiate their charitable donations.

Tax Records Archiving

We upload tax records to the foundation's online document archive and create back-ups at a secure data storage facility.

Grant Agreements

Ensure that the foundation's best interests are represented when making major gifts, such as funding capital campaigns, grants that involve naming rights, restricted grants, gifts of complex assets, or complicated, multi-year programs.

Grant History

Grant Status

Funding History

Expenses

Submit invoices and reimbursement requests, and monitor the foundation's spending by reviewing details on all expenses paid by the foundation through Foundation Source, as well as those awaiting processing. The expense module includes built-in compliance monitoring that highlights potential compliance issues and helps prevent disbursements that might result in a penalty.
